## We started small

1991

Who could have imagined that one woman's little act of kindness would go on to make such a big difference to so many children's lives. It was 1991 and Sally Bishop was determined to raise the money needed to buy a powered wheelchair for her neighbour's disabled son – knowing how it would completely transform his life, and help him become everything he could be.

Setting up 'HQ' in her front room, she began making calls to people who might be able to help and soon had enough donations to buy the chair. But this was only the beginning. In the next few months more families would contact her for help and in 1992 Action for Kids was formed. With the help of supporters, the charity continued to grow to meet the many calls for help – eventually expanding to include a maintenance programme and is one of the only charities in the UK to help fund repairs to the mobility equipment it provides. AFK also supports young people to realise their ambitions through a far-reaching programme of employment support training and job coaching. We believe in removing the social barriers that disable people from living an engaged and fulfilling life. We tell all our students and young people: you don't need to change; society does.

Sally retired in 2012 and collected a well-deserved OBE later that year. However, the work of AFK, as it's now known, goes on and the charity is as dedicated as ever to empowering disabled children and young people.


We've already been supporting children and young people for decades. With your help, we'll be here to support them for many more.

As you can imagine, much of the equipment we provide to young people, that isn't available on the NHS, can be very expensive – as is the upkeep and maintenance. But it can completely change their lives and give them the independence they deserve. By including a gift to us in your Will, you will be helping to give this amazing support to even more young people for many years to come.

And even when you are no longer here, your kindness will live on by helping to give young people their vital first steps into the workplace. Our specialist Job Coaches provide skills training and real-world work experience, which can lead to exciting job opportunities and support into paid employment.

Your generous gift will also help AFK plan for the future. As the world changes, we will need to change with it. Making sure that the support we give to disabled and neurodiverse children and young people is precisely what they need to live their very best lives.

## It might only take a little of your time.

Making your Will - or updating it - can feel like it will be a BIG task. You might even think that you don't need one. However, the truth is that everyone, no matter their age or situation should have one, and it's a lot simpler than you might think.

#### So, where to start?

We would always recommend that you chat to a solicitor or professional Will writer. Do get in touch with us if there's any help you need finding a solicitor in your area.

Before your meeting, there's plenty you can do to prepare - which could save you time and money in the long run. Here's our 5-step plan:

#### Step 1.

#### First, put together a list of everything you own.

This list should include the obvious things - like your home, your car - but also any savings and investments you may have as well as items such as jewellery or record collections.

#### Step 2.

Then make a second list of everything you owe.

'Estate' may sound rather 'arand'. However, it just means everything that you'll be leaving behind in your Will. The easiest way to estimate it is by taking the cost of what you owe from the cost of everything you own.

# We're here – for the little questions and the **BIG** ones.

If you talk to someone who's made a gift in their Will, they'll often tell you that it was much simpler than they thought – and they wish they had done it sooner. In fact, there's more than one way to do it, so you can make sure that it's absolutely right for you and that your loved ones are provided for first.

You can tailor it to suit your needs. Generally speaking, there are four key ways in which you can make your gift:

#### 1. A pecuniary gift.

This simply refers to a gift where you are leaving a specific sum of money.

#### 2. A residuary gift.

This is where you leave a percentage of your estate to a charity – once any other taxes and costs have been covered. Some people choose to leave just a small percentage – every gift makes a difference.

#### 3. A specific gift.

This is a gift where you name an item you would like to leave to a charity – for instance, it might be a work of art, some stocks and shares or a piece of furniture.

#### 4. A reversionary gift.

Here you are leaving a specific asset... such as a house. Something that can be used by a beneficiary of AFK during their lifetime, after which it will revert to AFK.

### "So, what are the ways in which I can choose to make a gift in my Will?"

## My Will has already been written. Is it possible to update it... rather than completely rewriting it?

Yes. If the changes are straightforward, you can download and complete a codicil form at afkcharity.org/give-in-your-will. It's always worth talking to your solicitor about your wishes and the best way to achieve them.

#### 🖌 How would I actually word my gift? 🄊

A solicitor can help you with the precise wording to best reflect your wishes. However, here is an example to guide you:

I give XX% of the remainder of my estate/£(cash amount) to AFK, 12 Martin House, Regis Road, London NW5 3EW. Charity registration number 1068841 – for it's charitable purposes.
